RECONSTITUTION TRUST DEED

This Deed of Reconstitution is made on this 7th day of November 2024 by

Sri. K.RAMACHANDRA, S/o late Sri. Kaverappa, aged about 42 years and **Smt. Kavitha Ramachandra**, w/o Sri. Ramachandra, aged about 39 years (collectively, the "Authors" or "Settlers"), both residing at No. 340, A/B Aviksha, Nandi Riches Garden Main Road, 2nd Cross, Kalkere, NRI Layout, Horamavu, Bangalore 560043, as the original authors and trustees of the trust established by the Trust Deed dated 26th Day of November, 2014 (the "Trust Deed").

RECITALS

WHEREAS, the Authorsestablished a Trust through the "Trust Deed" to create the **SREE VAGDEVI EDUCATIONAL TRUST** (the "Trust") and initially appointed themselves as the trustees of the Trust;

WHEREAS, the Authors and Trustees now wish to amend the objectives and articles of the Trust Deed. The Board of Trustees has passed an unanimous resolution in the Board of Trustees meeting dated 4th Nov 2024 authorizing these amendments and also authorizing the Trustees to register this amendment Deed of the Trust.

NOW, THEREFORE, in consideration of the mutual agreements and covenants herein contained, the Trust Deed is amended as follows:

1. Co-opting additional Trustees and Resignation of existing Trustees

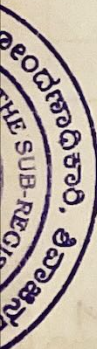
1.1 Co-opting of new Trustees:

The Trust board co-opted the following new Trustees to the board by way of resolution dated 4th Nov 2024 (**Annexure 1**) and the same has been accepted by the existing Trustees through acceptance letter (**Annexure 2**).

- ii. **Sri. Mohanarajan K. B**, S/o Balasundaram, aged 51 years and residing at 28A, KariamVallian St., Near Nehru Maithanam, Chocklingapuram, Aruppukotai, Viruthu Nagar - 626101

1.2 Resignation of Trustees: The existing Trustees **Sri. K.Ramachandra and Smt. Kavitha Ramachandra**, have resigned from their Trusteeship and all other positions in the Trust through the resignation letter dated 6th Nov 2024 (**Annexure 3**) and the same has been accepted by the new Trustees. A resolution to this effect accepting their resignation will also be passed by the Trust board in the next board meeting.



5. **New Executive Committee:** Sri. Krishnamurthy, Sri. Ramachandra and Smt. Kavitha have submitted their resignation through letters dated 4th Nov 2024 from their positions as Honorary President, President and Secretary respectively. The Trust Board has accepted the resignations in the Board meeting dated 4th Nov 2024. The Trust board can appoint New Executive Committee of it's choice.

6. **Appointment of Sponsoring Body:**

The Trust Board is desirous of reconstituting its articles for it to function more effectively and to facilitate it, RGBEE GLOBAL SOLUTIONS PRIVATE LIMITED (a company duly incorporated and registered under the Companies Act 2013, having its registered office at Survey No. 137, Kammanahalli Village, Off. Bannerghatta Road, BegurHobli, Bengaluru South Taluk, Bengaluru, Karnataka 560076) is inducted as a "Sponsoring Body" of the Trust.




7. The Objects and other clauses of the original trust deed is substituted and supplemented with the following clauses:

7.1. **OBJECTS**

- To provide scholarships and other incentives to desirous students.
- To Spread for promotion of education and learning in all branche
- To establish colleges to impart education in the area of higher education.
- To run education institutions and to provide quality education to all sections of students without any discrimination.

- A) The sponsoring body is willing to contribute its resources and expertise for betterment of trust's objects.







- B) The Sponsoring Body shall also provide the Trust with technical and managerial support as required. This support may include, but is not limited to, offering expertise, guidance, and resources in areas such as project management, financial management, human resources, information technology, and other relevant areas that will enhance the Trust's operations and effectiveness.
- C) The Sponsoring Body agrees to provide financial support to the Trust as a loan under the condition that all other possible sources of funding have been fully explored and exhausted. This support is intended as a last resort to ensure the continuity of the Trust's operations and objectives when no other financial resources are available. The Trust shall be required to document and provide evidence of its efforts to secure alternative funding before seeking financial assistance from the Sponsoring Body.
- D) The Sponsoring Body shall have the right to nominate up to two (2) trustees out of a maximum of four (4) trustees on the Trust's Board of Trustees. The nominated trustees shall be appointed in accordance with the Trust's governing documents and shall serve on the Board with the same rights, responsibilities, and duties as the other trustees.

7.3 POWER OF TRUSTEES







That the trust board shall have the following powers to manage all the assets and/or properties of the trust including the conduct of business.

- i. To appoint employees and to settle the terms of their service, remuneration and termination.
- ii. To look into the management of the trust.
- iii. To invest the funds of the trust, in the bank or in the purchase of company shares or securities or other movable and immovable properties;
- iv. To open the bank accounts in the name and on behalf of the trust and to operate the same;
- v. To enter into a partnership on behalf of the trust with any other party or parties;
- vi. To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- vii. To file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;

- viii. To accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- ix. To seek legal opinion of lawyers and/or Chartered Accountants as and when required.
- x. To nominate their representatives for any of the aforesaid purposes.

7.4 TRUSTEES AND THEIR APPOINTMENT

- Trustees are appointed with a tenure of three years. At the end of three years from the date of appointment of a Trustee (including the New Trustees co-opted in this deed) the trusteeship of the Trustee automatically ends and the sponsoring body shall appoint a successor in the place of such trustee.
- The number of trustees shall not be less than two but not more than five at any point of time.
- In case of any difference between the trustees, the opinion of the majority shall prevail.
- Any of the trustees may retire on giving one month's notice in writing to the other trustee(s).
- If any trustee dies or retires or becomes incapable or unfit to act, the sponsoring shall appoint a successor in the place of such trustee, with the approval of founder trustee by giving writing notice to the founder trustee.
- If at any time, the number of the trustees is less than two, the sponsoring body shall appoint one or more trustees.
- Upon the appointment of a new trustee the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees, with the duties and power of the trustees set out hereinabove in this deed.
- The trust being established and will operate subject to terms, conditions, or limitations in the Income tax Act, 1961 or any other Acts or Amendments governing Trusts.
- No amendments to the Trust Deed shall be made by the Trustees which may prove to be repugnant to the provisions of Section 2(15), 11,12,13 & 80 G of the Income Tax Act, 1961, as amended from time to time.

7.6 IRREVOCABLE

This Trust is irrevocable.

7.7 AMALGAMATION

The trustees may amalgamate the trust with another Charitable Trust or Institution having similar objects with prior permission of the Charity Commissioner/Court/any other law as may be applicable for the time being / with the approval of the founder trustee and trustees.

7.8 AMENDMENTS TO TRUST DEED

Any amendments in the Trust deed as approved by the Board of Trustees or as required by the governing laws, the the trustee authorized by the board is empowered to do all changes and register the trust deed with sub registrar.





7.9 WINDING UP

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Board of Trustees, but the same shall be transferred to another Charitable Trust/ Society whose objects are similar to those of this Trust/Society and which enjoys recognition under 80 G of the Income Tax Act, 1961 as amended from time to time and the same shall be intimated to the founder trustees in written notice with one month prior notice.

The Trustees shall be indemnified against all losses and liabilities incurred by them in the execution of the Trust and shall have a lien over the funds and properties of the Trust for such indemnity.







Resolution 2:
